

# Welcome to the long-awaited feedback from Hon Chris Hipkins – Minister for Education.

The below are extracts, word for word, from the Ministers "PROPOSAL FOR CHANGE" The document prior to this was a "DRAFT PROPOSAL" 2018.

**Proposal** (items being recommended for consideration) dated 18/2/2019 (currently nothing has been changed, any changes will be transitioned to ensure minimum disruption to services and parents).

- 1 I seek Cabinet's agreement to:
  - 1.1 Changes to home-based ECE arising out of the Review of Home-Based ECE (the review)
  - 1.2 Criteria to draw down the Budget 2018 cost adjustment for Home-Based ECE held in contingency aimed at incentivising quality.

## **Executive summary**

- I seek agreement to move towards a qualified home-based ECE workforce, with all educators **eventually** being required to hold, or be actively working toward, a Level 4 ECE qualification..... or higher.
- 7 I propose a suite of changes to strengthen key roles within homebased ECE to allow for improved oversight of the sector
  - 7.1 Introducing new requirements for service providers, including health and safety training and professional development.
  - 7.2 strengthening the oversight role of the teacher-qualified co-ordinator
  - 7.3 strengthening the Education Review Office 's role
  - 7.4 see document (improve Ministry oversight)

Transitioning to a fully qualified workforce

- During the transition period, the Teriary Education Commission will also work with tertiary education providers to encourage flexible delivery options that allow educators to balance home and work commitments
- I also realise that a substantial group of educators....., already hold a Level 3 qualification.... I propose that this group of educators are "grand-parented" through recognising their qualification as equivalent to a Level 4 ECE qualification.....

### The proposals NOT being recommended (they have been thrown out)

Increasing Visiting Teacher visits

Making Educators become employees
Including Educators children (enrolled at school) part of the 1:4 ratio

### How will this affect you?

This is still a "PROPOSAL FOR CHANGE"...... Currently nothing has been confirmed.

To enable these proposed changes there are many changes to be made at Government level to policy, law, regulations, funding, to name a few. THERE IS A LOT OF WORK YET TO BE DONE.

WE HAVE TIME – changes will be made in consultation with the homebased sector, and transitioned over a period of time.
